Resolutions must be submitted to TAASA for review by the board in advance. The deadline for submission is **SUNDAY, OCTOBER 21st, 2007 at 5:00PM.**

Unless renewed, resolutions automatically expire 4 years after passage.

Diversity

WHEREAS, TAASA is committed to providing support and advocacy services to all Texans affected by sexual violence; and
WHEREAS, a community consists of people from different races, national origins, and cultural backgrounds; and
WHEREAS, services for various groups of people are currently limited or non-existent; and
WHEREAS, diversity of service providers across Texas is limited; therefore be it
RESOLVED, that TAASA and its member programs will be responsive to all victims of sexual violence including, but not limited to, diverse populations, male victims, incarcerated persons, human trafficking victims, sex industry workers, gay/lesbian/bisexual/transgendered victims, and military personnel; be it further
RESOLVED, that TAASA members will actively encourage and recruit from our respective communities people with diverse races, national origins, and cultural backgrounds to volunteer and be employed at rape crisis centers and participate on the TAASA Board of Directors.
